**The agency estimates an average of eight (8) hours of research and records review, per program, per request. The average hourly rate per responding FTE is \$30.39. The agency estimates an expended salary amount for each request at \$243.12. With 38 requests received, and processed in FY19, the estimated total amount expended in personnel costs by the agency is approximately \$7,293.60.*
